



# Participant Information and Release Form

## **"The Dragon Raid" Release and Waiver of Liability, Assumption of Risk, Indemnity and Parental Consent Agreement.**

In consideration of participating in The Dragon Raid event, I represent that I understand the nature of motorcycle ride events and that I am qualified, in good health, in proper physical condition and adequately trained and licensed to participate in this type of event. I attest and verify that my vehicle/motorcycle is in good working order. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue in the Activity. I understand and agree to cooperate with the event organizers. If I fail to do so, I will be dismissed from the event without refund and/or compensation.

I hereby acknowledge that I have sole responsibility for my personal possessions and equipment during the event or its related activities. I hereby grant to any and all of the foregoing the use of any photograph, videotape, motion picture or any other record of this event for any purposes whatsoever including broadcasts, telecasts, internet, and the press as they pertain to the event.

I fully understand that motorcycle ride events involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inaction's, those of other participating in the event, the conditions in which the event takes place, or the negligence of the "releasees" named below, and that there may be other risks either not know to me or not readily foreseeable at this time, and I fully accept and assume all such risks and all responsibility for losses, costs and damages I incur as a result of participation in the Activity.

I hereby release, discharge and covenant not to sue The Dragon Raid, its respective administrators, directors, agents, officers, volunteers, and employees other participants, any sponsors, advertisers, if applicable, owners and lessors of premises on which the Activity takes place, (each considered on of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "RELEASEES" or otherwise, including rescue operations and I further agree that if despite this release, wavier of liability and assumption of risk, I or anyone on my and/or my minor child's behalf, makes a claim against any of the RELEASEES, I will indemnify, save, and hold harmless each of the RELEASEES from any loss, liability, damage, or cost which may incur as the result of such claim.

I hereby consent to receive medical treatment which my be deemed necessary in the event of an accident or medical emergency during this event and understand that I am solely responsible for all costs related to medical treatment, medical transportation and/or evacuation.

I have read this **RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, AND PARENTAL CONSENT AGREEMENT**, I understand that I have given up substantial rights by signing it and have signed it freely and without and inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this **AGREEMENT** is held to be invalid the balance, notwithstanding, shall continue in full force and effect. I represent that I rely wholly on my own judgment in executing this form, that I have had the opportunity to consult with anyone or consel of my choice before doing so, and that I freely consent to each of the provisions herein. **I FURTHER FULLY UNDERSTAND THAT THERE IS NO RIDER INSURANCE PROVIDED FOR THIS EVENT, THEREFORE DRIVERS/RIDERS MUST CARRY THEIR OWN ACCIDENT INSURANCE.**

### **Parental Consent**

And I, the minor's parent and/or legal guardian, understand the nature of the above referenced activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such activity. I hereby release, discharge, covenant not to sue and **AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS** each of the release es from all liability, claims, demands, losses, or damages, on the minor's account caused or alleged to have been caused in whole or in part by the negligence of the Release es or otherwise, including negligent rescue operations and further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of the above Release es, I **WILL INDEMNIFY, SAVE AND HOLD HARMLESS** each of the Release es from any litigation expenses, attorney fees, loss liability, damage, or cost any Releasee may incur as the result of any such claim.
